Local Government & Community Development Department (LG&CDD), Government of The Punjab launched a project “**Asset Management of Immovable Properties for Punjab TMAs**” in March 2015 to introduce transparency, efficiency and accountability through e-governance and ICT/GIS based solutions in TMAs. The project is being implemented by Punjab Municipal Development Fund Company (PMDFC). In this connection, municipal immovable properties data was collected by PMDFC with the assistance of TMA staff. A GIS based data base and web based software have been developed for municipal assets inventory and management.

PMDFC intends to arrange training of TMA officials.
